### **Redevelopment of 3 Downtown Buildings**

If downtown begins to look different, here's why...City Council approved three redevelopment projects that will bring new business and residential living downtown.

#### Art Deco Building, 213 W. State St.:

Urban Equity Properties plans to renovate this 11,700square-foot building into a mix of retail and office space. It will have two businesses on the ground floor and loft office space on the second and third floors.

#### Main and Mulberry, 134 N. Main St.:

Oliver Emerson Development plans to turn the former Trekk building, which was built in 1929 as the city's first Walgreens, into 14 residential lofts and a ground-floor business.

#### Watch Factory, 325 S. Madison St.:

Oliver Emerson Development plans to rehabilitate the three-story former Watch Factory, which was built in 1874, into 24 market-rate apartments. There will also be solarcovered parking spaces flanking both sides of the building.
